## INSTRUCTIONS FOR VIEWING VACANT PROPERTIES

TNT, Inc. allows applicants to view available, unfurnished properties without an Agent present, provided they have completed the Property Viewing Application or a Rental Application, submitted two forms of identification, paid a key deposit in the amount of \$20.00 per key and signed and dated this form below.

While viewing the property, please follow the following rules:

- Check all windows and doors to ensure they are closed and locked.
- Close all blinds and other window coverings.
- Make sure all lights are turned off.
- If the refrigerator is off, make sure the doors are completely open. If the refrigerator is on and the light is on, make sure the doors are shut.
- If you notice any cleaning issues or damages to the property, please notify TNT, Inc. immediately upon returning to the office.
- If you notice the "TNT, Inc." for rent sign is missing or damaged, please notify the office.
- DO NOT use the facilities (including restrooms).
- DO NOT change the temperature settings.
- Make sure the property is secure when leaving.

All properties will be inspected by a TNT, Inc. Maintenance Engineer after they have been viewed.

All keys must be returned to the TNT, Inc. office within two (2) hours of issuance. Applicants who do not return the key on time will lose their deposits, and will not be permitted to view additional properties in the future without an Agent present.
